Dear Parents,

As we are getting ready to complete another great year at the after school program, the time is also here to begin preparing for next fall. Registration is now open, and information is available online at www.MelroseSchools.com on the Education Stations' page. Please carefully remember registration is only considered valid once ALL necessary documents are received. The online registration form is only one component of complete registration.

Steps to Register

1. Please carefully read the parent handbook, which is accessible online. Understanding how the program works is a critical starting point for a smooth, collaborative year. Please contact us with any questions on content.
2. Download our "Parent Permission Packet" (PPP), and please print out the documents *in the current pdf format* (do not complete electronically and email to us). Fill out information requested on *all three required pages*, and the "Consent for Medication Administration" if relevant for your child. The completed PPP is required a minimum of two-weeks before students may attend. We ask this information to keep children safely supervised.
3. Complete online registration form, available at www.MelroseSchools.com on the EdS page. Your email is required to send electronic confirmation of your responses. If the schedule you registered for needs to change after the time you submit the online registration form, please contact us via email. State your child's full name, school, and the most recently desired schedule. *Schedule changes for August and September may not be made after the 8/15/17.* Thanks for understanding, as we are processing over 800 families' schedules in a small window of time.
4. *Please make out a check to "Melrose Public Schools" covering the \$46 registration fee AND first monthly rate payment.* This payment covers after school fees in both August and September. Please make checks payable to "Melrose Public Schools" and write your child's name in the memo line. DO NOT MAKE THIS PAYMENT ONLINE or VIA MCC PORTAL. EdS is switching online systems soon, and fall funds need to be directed accurately. If you are currently using bank-issued checks, please plan in advance to properly meet registration deadlines and payment destination. We appreciate your help in this matter.
5. Attach your check to the completed PPP, and mail or drop by your documents. *Please do not direct fall paperwork and payments to your child's school.* All information must initially be processed via our central offices. Please note central admin office hours during the summer are: Mon-Thur 7:30am-4:15pm.
